[1] There are 32 fully served unincorporated counties, 33 if you consider that Mid-Columbia Libraries and East Adams (Ritzville) Library District combine to fully serve unincorporated Adams County. Another 3 counties are partially served as follows: Fort Vancouver Regional Library District serves part of unincorporated Cowlitz County; Lopez Island, Orcas Island and San Juan Island Library Districts serve parts of unincorporated San Juan County; Central Skagit Library, La Conner Regional Library, Upper Skagit Library District and Sno-Isle Libraries serve parts of unincorporated Skagit County.

[2] Part of unincorporated Cowlitz County is served by Longview Public Library (a municipal library).

[3] Fort Vancouver Regional, a district library, and Longview Public Library, a municipal library, separately serve different portions of unincorporated Cowlitz County.

[4] Unserved population counts do not include unincorporated areas partially served by district or municipal libraries. There are 3 counties whose unincorporated areas are entirely without service: Lincoln, Wahkiakum and Kittitas (although in some cases there may be interlocal agreements in place to provide service to these unincorporated areas, due to the nature of these contracts, which fall outside the Federal definition of a Legal Service Area, the resident population has not been included in the count of those served). There are 3 counties with incomplete service: Cowlitz, San Juan and Skagit. Multiple library service areas combine to provide for full unincorporated county coverage in Adams County.
