An act relating

SECRETARY OF STATE

This is for people will now have traffic tickets violations will now get a 12 hours restricted Drivers License for any and all traffic tickets except wreck less driving tickets.

## New Section 1

Your drive time will become automatic from 7:00am to 7:00pm The Department of licensing mail notice to you that your driver licensed has been changed to 12 hours restricted Driver Licensing

You can change the 12 hours to fit your needs for work by applying what time you need with an additional department of licensing filling fee if you work split shift you have write in the times of the split shift for the hours you needed for the change of your drive time to the Department of licensing with a restatement fee. You must pay \$5.00 a month on at least one ticket you owe just get twelve hours minimum drive time.

How ever you can add more hours by paying \$5.00 for each additional hour which goes towards your traffic infractions fines.

If you miss your minimum of \$5.00 payment a month you have five business days to pay on your traffic infractions fines excluding holidays. Now if you miss your \$5.00 payment a month you have to pay for another restatement fee at department of licensing plus the \$5.00 minimum a month to pay on your traffic infractions. You can pay traffic infraction fines all off at any time and go back to a regular driver license

Or do time payment plain on your traffic infraction fines when get them all paid off you go back to a regular driver license. This will apply to ever one has a past owed traffic infractions or failed to a. appear in court or not filling out the back of your traffic infractions you are eligible for 12 Hour restricted Driver Licensing

Your receipt is your proof to law enforcement. Which law enforcement will request at the time of stop.

### Policies and purpose

This will put people back to work and keep their jobs.

This will also help all the people who don't live around mass transit systems like eastern Washington counties this new law will help the tax payer by not having build new jails systems. We will be able to keep the state service that we need from the steady income and with out creating new taxes

### Current law Effect

For some reason that not pay on there could traffic infractions due to a hard ship or what ever reason it happened financially to you. On the old system we have now.

The state will suspend you driver license.

For not reading department of licensing mail.

When you don't pay on traffic infractions or you just forgot to.

Or failed to appear in court or failed to fill out the back of your traffic ticket

Now if you get caught driving while licensed suspend under old law and get pulled over by law enforcement you lose your car your job this has happened many time to a lot of people.

Then you can't pay on your traffic infractions and then you get pulled over again for driving while licensed suspend then it you get pulled over again for driving while licensed suspend again and again just to try to pay the traffic infractions off while going to work so on and on now you end up unable to pay on your traffic fine at all and end up giving up paying on any traffic fine at all with poor paying jobs that take years to come out of the fine you owe the courts.

When you up in jail then unable to even keep up on the cost of living the next thing you end up living with some one else homes then end up homeless or have homeless families

All this has a very negative effect which is a very bad current law.

We need a new change to something better like a 12 hours restricted Drivers License for all the people.
