I, Sam Reed, Secretary of State of the State of Washington and custodian of its seal, hereby certify that, according to the records on file in my office, the attached copy of Initiative Measure No. 910 to the People is a true and correct copy as it was received by this office.

1 AN ACT Relating to vehicle license tab fees; amending RCW
2 46.04.310; and reenacting and amending RCW 46.16.0621.

3 BE IT ENACTED BY THE PEOPLE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 46.16.0621 and 2003 c 1 s 2 and 2002 c 352 s 7 are
5 each reenacted and amended to read as follows:

6 ~~(1) ((License tab fees are required to be \$30 per year for motor
7 vehicles, regardless of year, value, make, or model.~~

8 ~~—(2))~~ For the purposes of this section, "license tab fees" are
9 defined as the general fees paid annually for licensing motor vehicles
10 and trailers ~~((as defined in RCW 46.04.620 and 46.04.623, including
11 cars, sport utility vehicles, motorcycles, and motor homes))~~. Trailers
12 licensed under RCW 46.16.068 or 46.16.085 and campers licensed under
13 RCW 46.16.505 are not required to pay license tab fees under this
14 section.

15 (2) License tab fees are 0.416 percent of the value of the vehicle,
16 with a maximum annual fee of two hundred fifty dollars and a minimum
17 annual fee of thirty dollars. The department shall calculate the value
18 of each vehicle according to the following depreciation schedule:

12 (3) The vehicle's original selling price may be established by
13 either the dealer's contract of sale to the original purchaser, or if
14 that is not available, then by the manufacturer's suggested retail
15 price (MSRP) as shown in documents generally accepted in the retail
16 vehicle business.

17 **Sec. 2.** RCW 46.04.310 and 1961 c 12 s 46.04.310 are each amended
18 to read as follows:

19 "Motor truck" means any motor vehicle designed or used primarily
20 for the transportation of commodities, merchandise, produce, freight,
21 or animals.
